4. First-aid Measures

4.1 Description of First Aid Measures

8.2 Exposure controls

Personal Protection

RESPIRATORY PROTECTION: In order to avoid inhalation of spray-mist and sanding dust, all spraying and sanding must be done wearing adequate respirator. Wear a battery

powered assisted air-fed mask during spraying operations and long-term exposure.
