## 4. First-aid Measures

### 4.1 Description of First Aid Measures

## 8.2 Exposure controls

### Personal Protection

**RESPIRATORY PROTECTION:** In order to avoid inhalation of spray-mist and sanding dust, all spraying and sanding must be done wearing adequate respirator. Use compressed air or fresh air breathing apparatus in closed compartments. Wear respiratory protection with combination filter (dust and gas filter, EN 14387:2004+A1:2008) during spraying operations: Gas filter type A2 (organic substances). Dust filter P3 (for fine dust). Use only with ventilation to keep levels below exposure guidelines reported in this document. User should test and monitor exposure levels to ensure all personnel are below guidelines. If not sure, or not able to monitor, use State or federally approved supplied air respirator. For silica containing coatings in a liquid state, and/or if no exposure limits are established above, air-supplied respirators are generally not required.
